

Denver Area Council 2019 Summer Camp Fees, Incentives, & Timelines

2019 Incentives

Signup Special: All Scouts, BSA Troops that sign up for summer camp 2019 with their \$100 deposit by August 31, 2018 will be put into a special drawing to be held at Scout Show 2019, for a \$2,500 credit toward 2019 camp fees. Since the drawing will be held at Scout Show 2019, all payments must be current and cannot be behind or your troop will be ineligible for the drawing. Credit has no value and cannot be credited back to a troop for cash.

Loyalty Unit - Weekend Camping: All units signed up for Summer Camp 2019 will be eligible to receive loyalty pricing for weekend camping at both Peaceful Valley Scout Ranch and Tahosa High Adventure Base from January 1 – December 31, 2019. Once a deposit has been made, you will begin to receive loyalty pricing for PV and TH, even if before January 1, 2019.

Registered Scoutmaster Gift: For every registered Scoutmaster that attends Summer Camp 2019 for the duration of the week with their troop, will receive a special Scoutmaster gift. This will be above and beyond the unit leader gift that we give to every adult and summer camp Scoutmaster who stays for the entire week.

Summer Camp Scoutmaster Gift: For every summer camp Scoutmaster that attends Summer Camp 2019 for the duration of the week with their troop, will receive a summer camp Scoutmaster gift. This will be above and beyond the unit leader gift that we give to every adult who stays for the entire week.

Adult Leader Gift: For every Scouts, BSA adult leader that is registered to attend Summer Camp 2019 for the duration of the week with their troop, will receive a special unit leader gift.

Second Opportunities: If a Scout is looking to attend a second week of camp at either PV or TH, we will discount the second week of camp by 25% (discount will be applied to the lower of the two camps)

Trifecta of Tahosa: For any Scout that attends NYLT, EaglePoint or Tahosa Trek, and Alpine Adventure in the same summer, we will discount one of the non-NYLT camps by 50%, plus the youth will receive a Trifecta of Tahosa gift.

Free T-Shirts: For all units that have paid their camp fees in full by April 1, 2019 (Troops) and May 1, 2019 (Packs), each registered Scout, as of that date, will receive a complimentary T-shirt.

2019 fees matching Opportunity:

Boy Scout Camp: For every troop that registers with a troop deposit and makes an initial payment of at least \$5.00 per Scout* by December 15, 2018 will receive a match from Denver Area Council. The Denver Area Council will match up to \$20.00 per Scout.

Cub Scout Resident Camp: For every pack that registers with a pack deposit and makes an initial payment of at least \$5.00 per Scout* by December 15, 2018 will receive a match from the Denver Area Council. The Denver Area Council will match up to \$10.00 per Cub Scout.

The Denver Area Council matching funds are available on a first come first serve basis until the \$40,000 matching fund is depleted. Once the fund is depleted or December 15, whichever comes first, the match will be discontinued. All matching funds belong to the Denver Area Council, BSA and no cash value other than for use at a Denver Area Council long term resident camp for Scouts BSA, Webelos Extreme Scouting Trek, or Magness Adventure Camp.

*Scout Deposits must include names and only available to registered Scouts of the Boy Scouts of America. Scouts do not need to be registered in the Denver Area Council. Matching fees are non-transferrable and are non-refundable. Matching funds will be applied upon completion of the summer camp program.

DAC - Investment in Character (IC) Discount:** Continued from 2018 for 2019, a IC discount is being applied – \$20 Maximum per Denver Area Council Scout (must complete all bench marks in order and not miss one, to receive full credit)

Cub Scouts (Good for Scouts attending Magness Adventure Camp or W.E.S.T.)

- Schedule your IC presentation by January 15, 2019 and conduct your IC presentation by March 31, 2019 – receive a \$5 credit per Scout
- Reach your IC Goal by April 1, 2019 – receive an additional \$2.50 credit per Scout
- Exceed your IC goal by 10%, no later than April 15, 2019 – receive an additional \$2.50 credit per Scout

Scouts, BSA (Good for Scouts attending Angel Fire, Cris Dobbins, Camp Dietler, EaglePoint, Tahosa Trek, Alpine Adventure or NYLT.)

- Schedule your IC presentation by December 31, 2018 and conduct your IC presentation by March 31, 2019 – receive a \$10 credit per Scout
- Reach your IC Goal by April 1, 2019 – receive an additional \$5 credit per Scout
- Exceed your IC goal by 10%, no later than April 15, 2019 – receive an additional \$5 credit per Scout

2019 Fee Dates

Payment Information (Please note changes from previous years):

1. **Deposit** - \$100 nonrefundable **deposit** is due to hold your 2019 reservation. This fee will be credited to your camp fees for 2019.

2. By **November 5, 2018**, a Scout non-refundable deposit of \$50.00 per camper for the above number of Scouts listed is due. Understand that the Denver Area Council Camping Department can only assure and prepare the number of spaces for which payment has been received. If not paid, your reservation will be canceled and the **deposit of \$100** will not be refunded.

3. By **February 4, 2019**, an additional payment of \$100.00* per camper for the registered number of Scouts is due.

**The number of Scouts provided on this date will be used to "lock in" your number of Scouts attending summer camp 2019. Prior to this date, you will not be penalized if you lower the number of Scouts that will attend camp.*

4. By **April 1, 2019**, an additional \$100.00 (total \$250.00) per camper for the above number of Scouts, and the full applicable leader fee for each adult beyond the two (2) free leaders.

Note: Access to the merit badge sign-up website will not be possible if this payment is not made.

5. By **May 6, 2019**, the outstanding balance for each camper and adult is due.

6. **Scouts cancelled before May 16, 2019** will be refunded full amount of payments less the \$50 non-refundable deposit. Swapping of Scouts is allowed and the Denver Area Council will not penalize for swapping a Scout for another, provided that the count does not lower.

7. **Scouts cancelled After May 15, 2019** will NOT be refunded their camp payment, as by that time, planning and purchases have been made. Swapping of Scouts is allowed and the Denver Area Council will not penalize for swapping a Scout for another, provided that the count does not change. However, if a physician provides a letter stating that the reason the participant cannot attend is medical, or the unit leader provides a note stating that there was a death in the immediate family, the participants will receive a full refund, less the \$50 non-refundable deposit.

8. **“No Show” Scouts:** If you have “No Show” Scouts at your 2019 Summer Camp check-in, causing your overall number to decrease from your preregistration numbers, your unit may be subject to a \$100 fee per “No-Show” Scout in addition to the full camp fee. Please keep us posted with your current participation numbers.

9. **Refunds While Attending Camp:** If a Scout or participant becomes ill or has an injury while attending camp and is sent home prior to Wednesday by order of the camp Medical Director, the Scout will receive a 50% refund of fees paid. If a Scout or participant goes home after Wednesday, they **WILL NOT** receive any type of refund of registration fees nor program fees. Scouts or participants who leave camp for behavioral issues, by their own choice, or for any other reason, **WILL NOT** receive a refund of registration fees nor program fees. The unit’s Scoutmaster, Cubmaster, or Committee Chair should make a refund request in writing to the Denver Area Council Camping Department. A *“Refund Request Form”* will be provided at camp, upon settling camp fees with the Camp Business manager. The form is also available on the Council website, www.DenverBoyScouts.org/Camps.

- All *“Refund Request Forms”* must be received in the Denver office no later than seven (7) business days at the end of your stay at camp.
- *“Refund Request Forms”* will NOT be accepted after August 15th.
- All refunds will be issued no later than 60 days after the request is made.
