# Job Summary

Assist the permanent Ranger with repair, maintenance of buildings, vehicles, equipment, campsites, organization of maintenance facilities, organizing service projects, implementation of the Council Conservation Plan and help and support the camp program and other personnel.

#### Job Description

#### **ROLE AND RESPONSIBILITIES**

- Maintain and be particularly alert to conditions around camp that affect health, safety, sanitation and housekeeping.
- Be knowledgeable in and ready to implement and respond to camp emergencies. Follow directions from the Camp Director and Ranger.
- Maintain the landscaping around camp such as grass mowing, clearing slash, etc.
- Assist in the maintenance and repair of buildings and facilities which includes painting, light bulb changing, minor and basic repairs and preventative maintenance.
- Perform custodial duties which includes sweeping, mopping, scrubbing, sanitation of bathrooms and showers, and washing windows.
- Collect trash around camp daily. Dispose in trash containers.
- Work with the Camp Director and Program Director to support the needs of the camp program and operation.
- Organize, supervise and provide leadership to conservation projects for units and NYLT.
- Be familiar with camp safety rules and enforce as needed.
- Run errands off camp such as driving Trek crews, supply runs and deliveries/pickup from the Council office in Denver or Peaceful Valley Scout Ranch in Elbert.
- Participate in camp-wide activities.
- Assist in the set up and take down of all camp facilities.
- Submit a "closing report" at the end of the season which includes inventories, daily duties and suggestions for improvement the following year.
- Other duties as assigned.
