The Climbing Director is responsible for ensuring campers receive a safe, fun, quality and educational climbing program.

Job Description

ROLE AND RESPONSIBILITIES

- Train, supervise and evaluate direct report staff.
- Ensure BSA climbing procedures are followed.
- Instruct campers in rock climbing and safety. Offer a quality program.
- Maintain paperwork and ensure completeness and submit on time.
- Organize off-site climbs. Coordinate with the Camp Director, EaglePoint Program Director and Health Officer.
- Evaluate staff in the middle and end of the season.
- Participate in camp-wide activities.
- Assist in the set up and take down of all camp facilities.
- Submit a "closing report" at the end of the season which includes inventories, daily duties and suggestions for improvement the following year.
- Other duties as assigned.

- Must have the physical endurance to participate in rock climbing activities
- Must be able to identify and respond to climbing emergencies with the proper procedure/maneuvers
- Must be able to pass a background check from the TRAILS database, CBI and the FBI
- Must be able to become a member of the Boy Scouts of America
