# **Job Summary**

Direct and supervise the shelter operations to include dining, housing and restrooms for campers. Supervise and provide guidance to assigned staff members to ensure a successful operation.

#### **Job Description**

#### **ROLE AND RESPONSIBILITIES**

- Train and supervise camp staff in shelter protocol to include food service, cleaning, maintenance, and program.
- Create and oversee shelter cleaning schedule. Ensure cleanliness of shelter to include dining room, restrooms and showers, storage rooms, personal living quarters, exterior and tent area.
- Manage the food service at each meal. Ensure timely start, portion sizes are correct, and health codes are being followed.
- Be particularly alert to conditions that affect health, safety, security, and housekeeping.
- Perform custodial duties to include sweeping, mopping, wiping and washing, trash disposal, stocking supplies, sanitizing and disinfecting.
- Be knowledgeable in and ready to implement camp emergency procedures.
- Supervise, train and evaluate direct report staff. Ensure classes and programs are being presented accurately.
- Ensure program areas are well-stocked with supplies, including shelter and program areas.
- Assist in developing and implementing the program theme.
- Communicate often with the Camp and Program Director.
- Participate in camp-wide activities.
- Assist in the set up and take down of all camp facilities.
- Submit a "closing report" at the end of the season which includes inventories, daily duties and suggestions for improvement the following year.
- Other duties as assigned.
